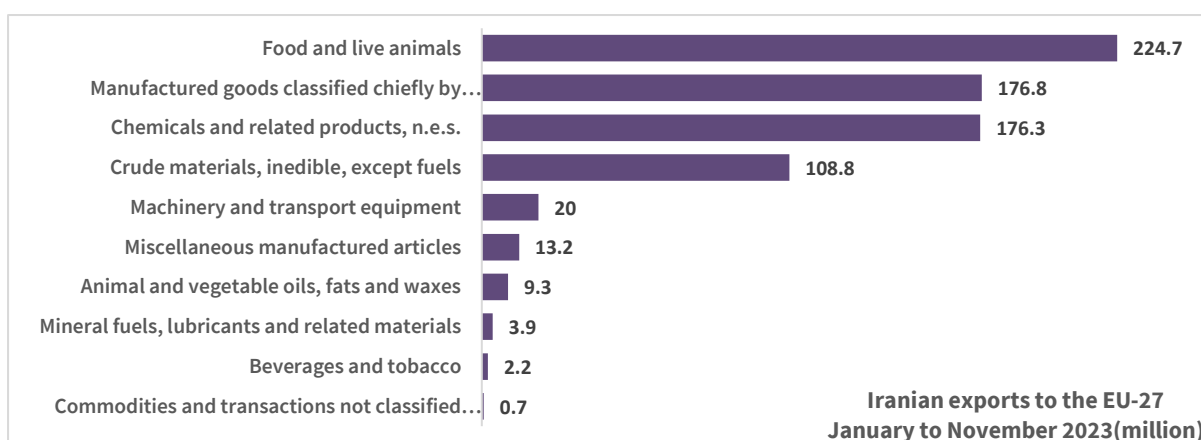
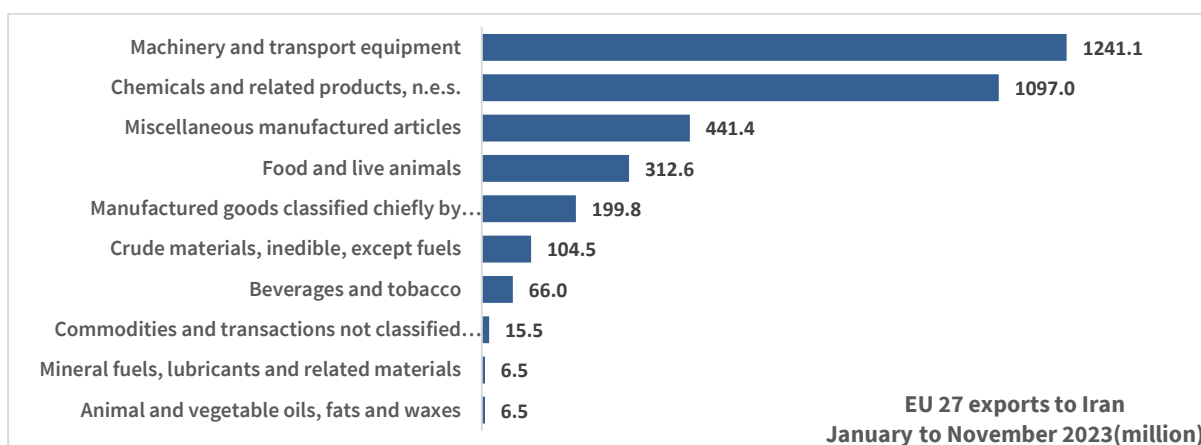
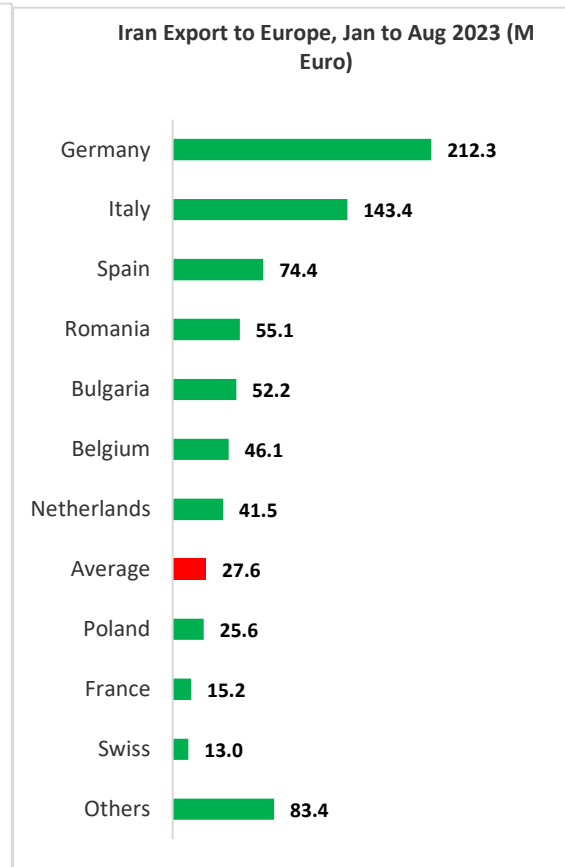
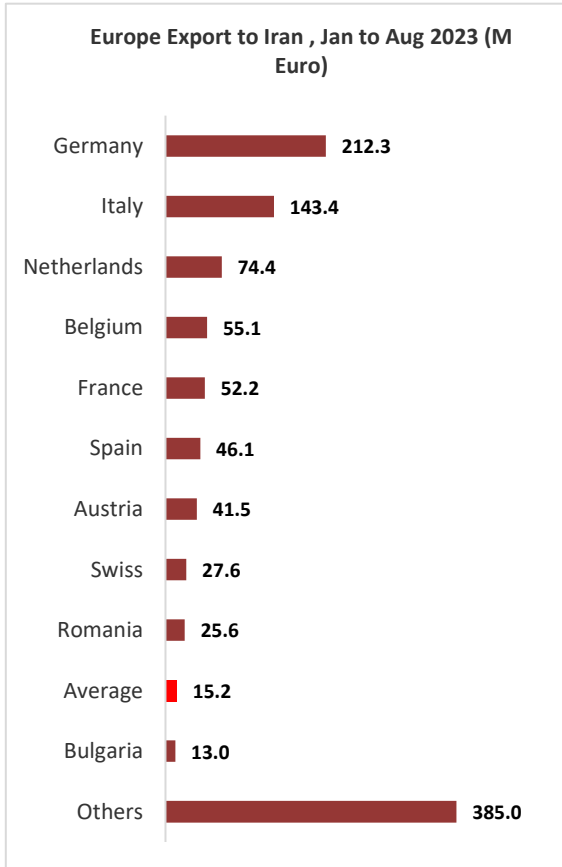
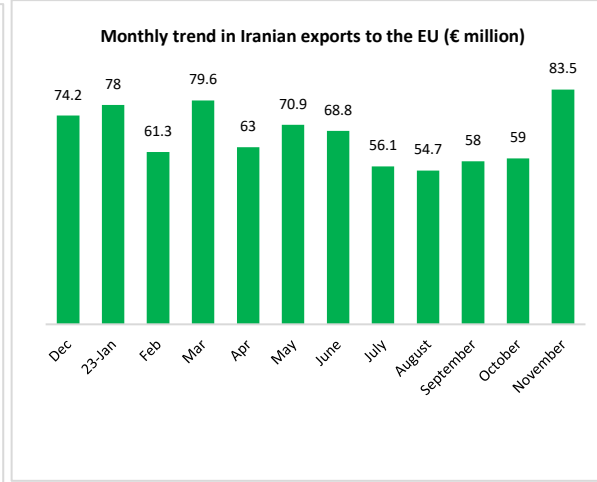
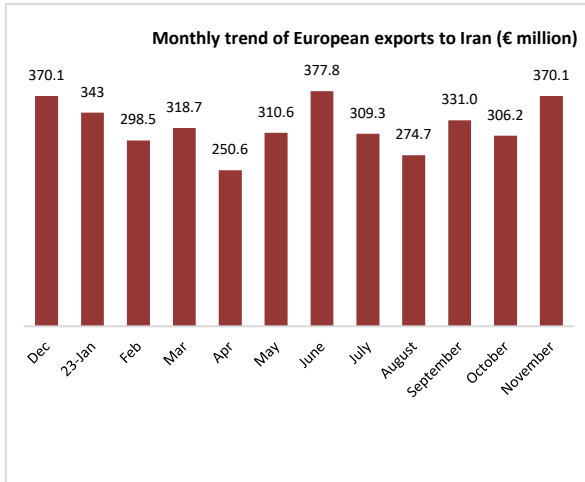


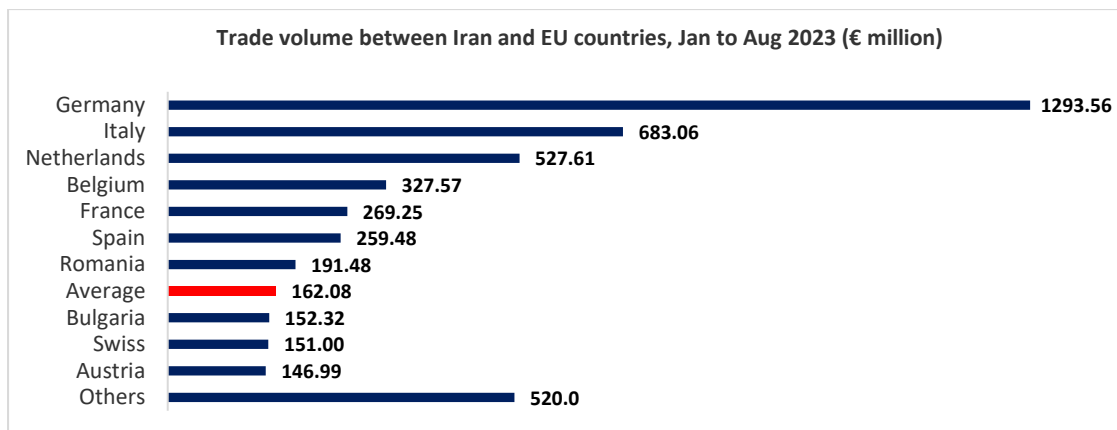
Trade between Iran and EU 27 - January to November 2023

- Trading volume from January to November 2022: 4.2 billion euros, **-12 percent** compared to the same period last year (4.8 billion euros)
 - European exports: 3.5 billion euros, **-9 percent** compared to the same period last year (3.8 billion euros)
 - Iranian exports: 736 million euros, **-25 percent** compared to the same period last year (982 million euros)

- Trading volume in November 2023: 454 million euros, **+6 percent** compared to the same month last year (427 million euros)
 - European exports: 370 million euros, **+10 percent** compared to the same month last year (336 million euros)
 - Iranian exports: 84 million euros, **-9 percent** compared with the same month last year (92 million euros)
