


Trade between Iran and EU 27 - January to December 2023

- Trading volume from January to December 2023: 4.7 billion euros, **-11 percent** compared to the same period last year (5.5 billion euros)
 - European exports: 3.8 billion euros, -7 percent compared to the same period last year (4.2 billion euros)
 - Iranian exports: 799 million euros, -24 percent compared to the same period last year (1056 million euros)
- Trading volume in December 2023: 465 million euros, **+5 percent** compared to the same month last year (445 million euros)
 - European exports: 403 million euros, +9 percent compared to the same month last year (370 million euros)
 - Iranian exports: 62 million euros, -16 percent compared with the same month last year (74 million euros)








