
Trade between Iran and Germany - January to March 2024

- Trade volume from January to March 2024: 406 million euros, **+10 percent** compared to the same period last year (369 million euros)
 - German exports: 344 million euros, +19 percent compared to the same period last year
 (290 million euros)
 - Iranian exports: 61 million euros, -22 percent compared to the same period last year (79 million euros)
- Trade volume in March 2024: 123 million euros, -1 percent compared to the same month last year (124 million euros)
 - German exports: 103.3 million euros, +12 percent compared to the same month last year
 (92.2 million euros)
 - Iranian exports: 20 million euros, -37 percent compared to the same month last year
 (31.8 million euros)
