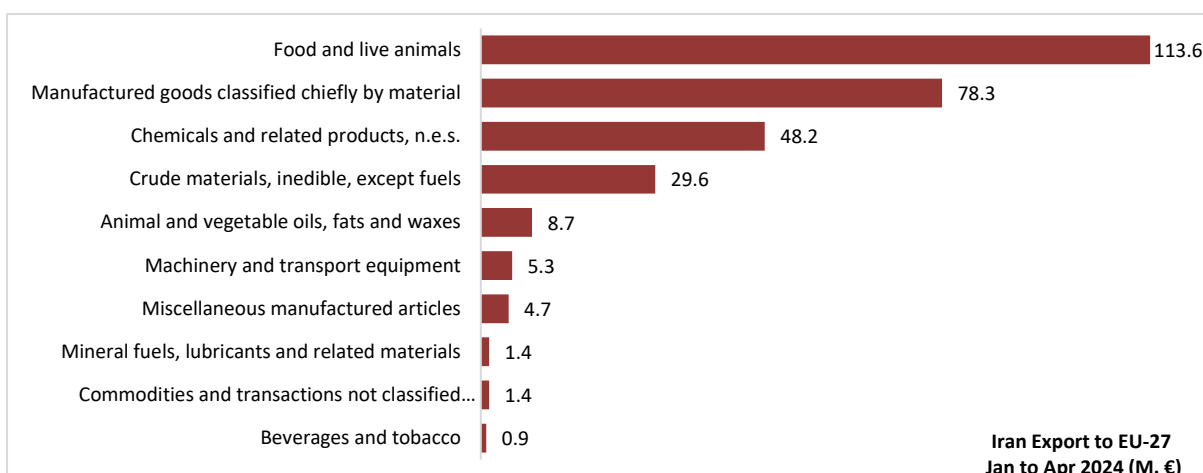
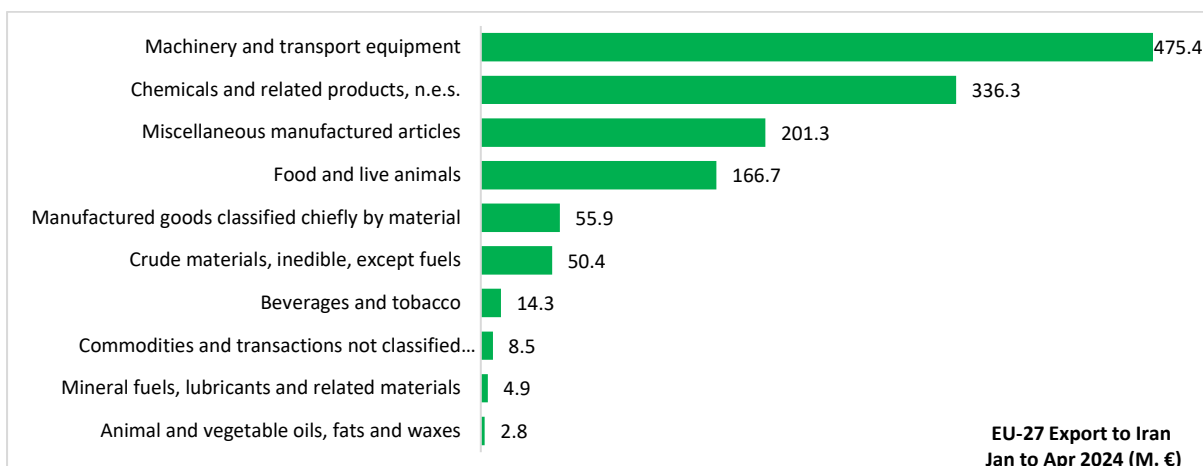
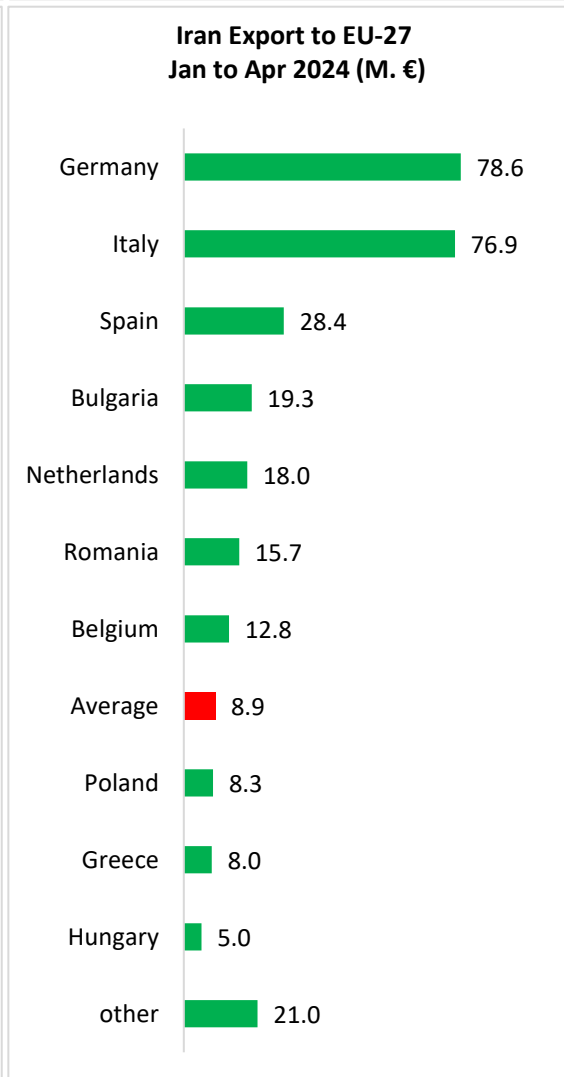
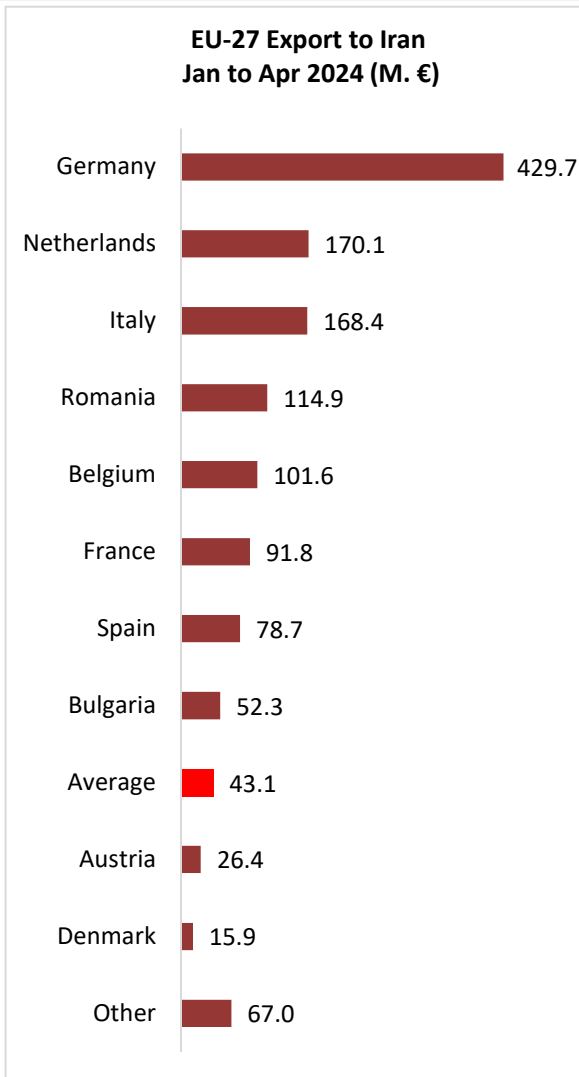
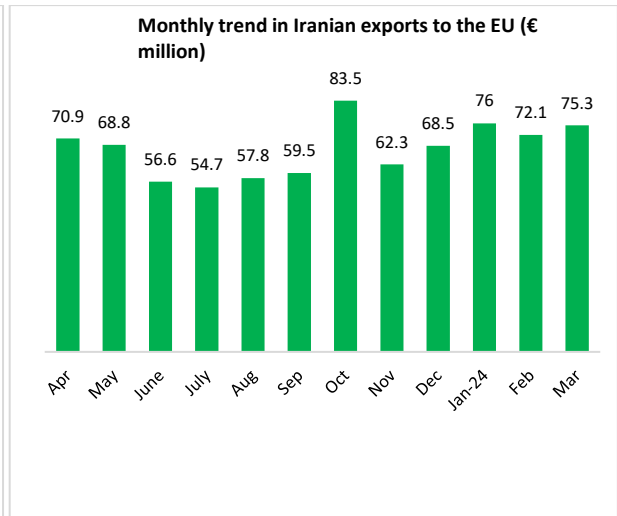
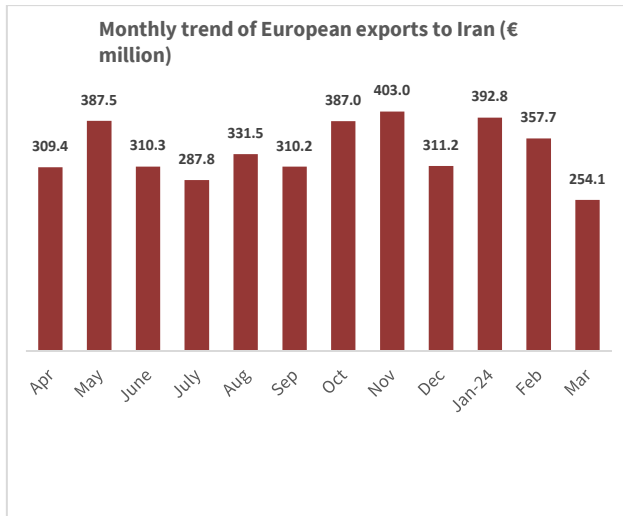


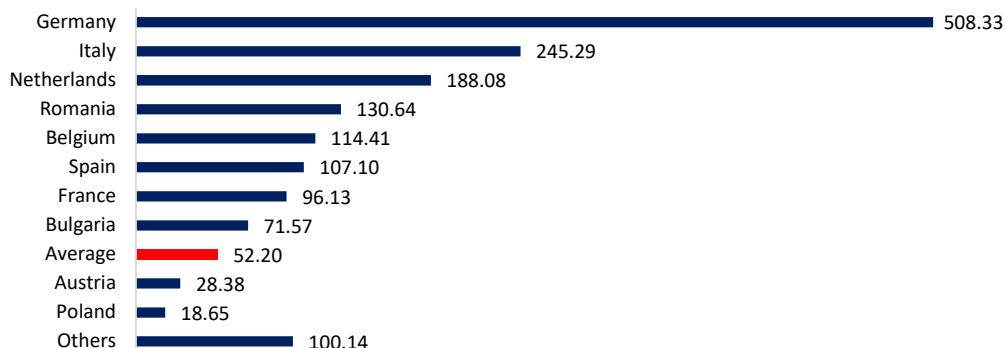
Trade between Iran and EU 27 - January to April 2024

- Trading volume from January to April 2024: 1.61 billion euros, **+8 percent** compared to the same period last year (1.5 billion euros)
 - European exports: 1.32 billion euros, **+9 percent** compared to the same period last year (1.21 billion euros)
 - Iranian exports: 292 million euros, **+2 percent** compared to the same period last year (286 million euros)
- Trading volume in April 2024: 329 million euros, **+5 percent** compared to the same month last year (314 million euros)
 - European exports: 254 million euros, **+1 percent** compared to the same month last year (251 million euros)
 - Iranian exports: 75 million euros, **+20 percent** compared with the same month last year (63 million euros)
