

## Trade between Iran and Germany - January to April 2024

- Trade volume from January to April 2024: 513 million euros, +9 percent compared to the same period last year (469 million euros)
  - German exports: 430 million euros, +15 percent compared to the same period last year
    (373 million euros)
  - Iranian exports: 84 million euros, -14 percent compared to the same period last year (97 million euros)
- Trade volume in April 2024: 123 million euros, **+6 percent** compared to the same month last year (101 million euros)
  - German exports: 85 million euros, +2 percent compared to the same month last year (83 million euros)
  - Iranian exports: 22 million euros, +27 percent compared to the same month last year
    (17.4 million euros)
