
Trade between Iran and Germany - January to May 2024

• Trade volume from January to May 2024: 622 million euros, **+8 percent** compared to the same period last year (576 million euros)

 German exports: 521 million euros, +13 percent compared to the same period last year (460 million euros)

Iranian exports: 100 million euros, -14 percent compared to the same period last year (116 million euros)

- Trade volume in May 2024: 108 million euros, +1 percent compared to the same month last year (106.5 million euros)
 - German exports: 91 million euros, +5 percent compared to the same month last year (87 million euros)
 - Iranian exports: 16.6 million euros, -15 percent compared to the same month last year (19.6 million euros)
