
## Trade between Iran and Germany - January to August 2024


• Trade volume from January to August 2024: 1.03 billion euros, **+10 percent** compared to the same period last year (939 million euros)

 German exports: 875 million euros, +14 percent compared to the same period last year (764 million euros)

• Iranian exports: 158 million euros, -10 percent compared to the same period last year (175 million euros)

- Trade volume in August 2024: 144 million euros, +17 percent compared to the same month last year (123 million euros)
  - German exports: 125 million euros, +24 percent compared to the same month last year (101 million euros)
  - Iranian exports: 18.8 million euros, -15 percent compared to the same month last year (22.2 million euros)




