


Trade between Iran and EU 27 - January to August 2024

- Trading volume from January to August 2024: 3.1 billion euros, +2 percent compared to the same period last year (3 billion euros)
 - European exports: 2.54 billion euros, +2 percent compared to the same period last year (2.5 billion euros)
 - Iranian exports: 561 million euros, +5 percent compared to the same period last year (537 million euros)
- Trading volume in August 2024: 337 million euros, **-1 percent** compared to the same month last year (341 million euros)
 - European exports: 280 million euros, -2 percent compared to the same month last year (281 million euros)
 - Iranian exports: 57 million euros, +4 percent compared with the same month last year (55 million euros)









EU-27 Exporte nach Iran Januar bis August 2024 (Mio. €)
