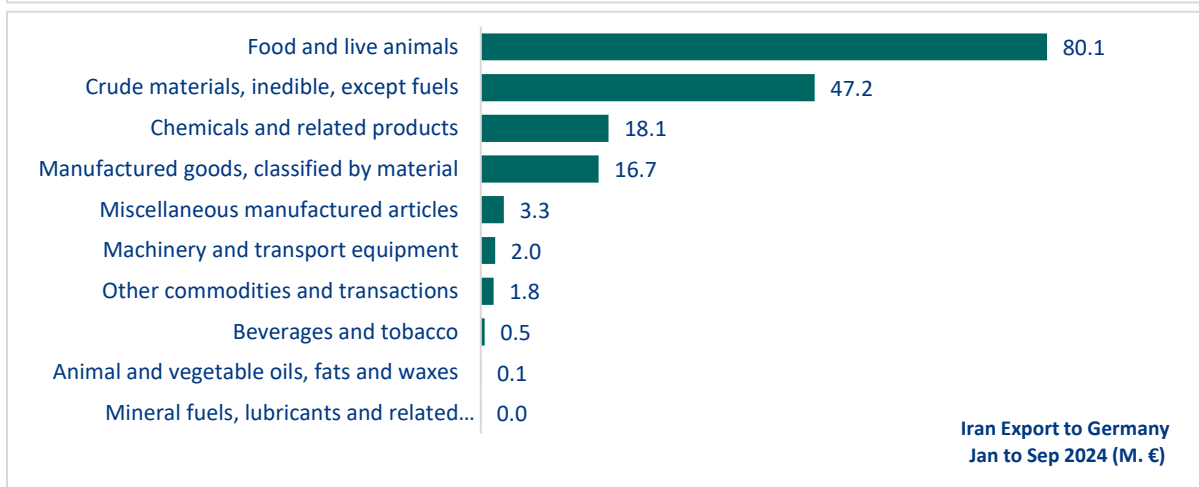
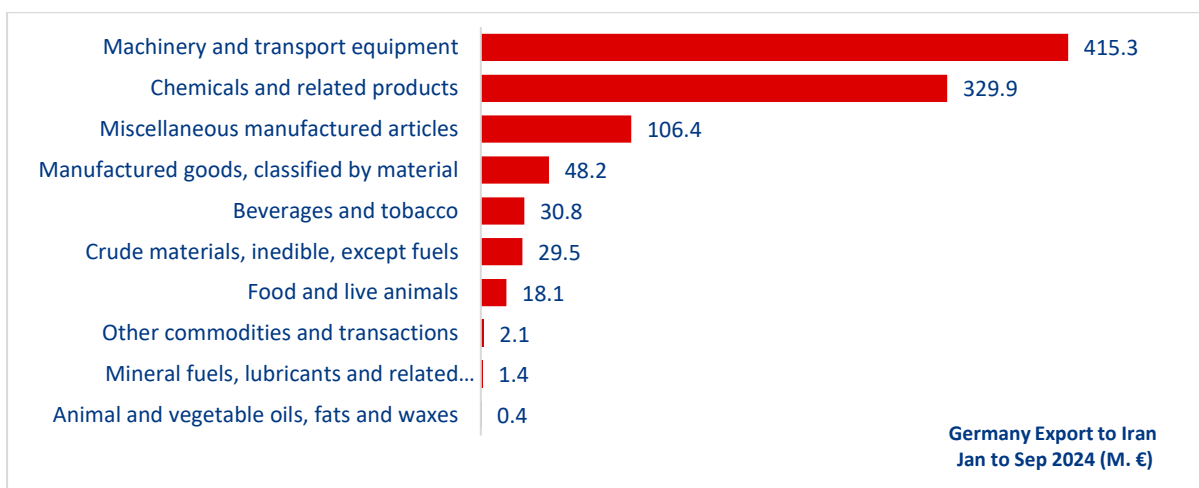
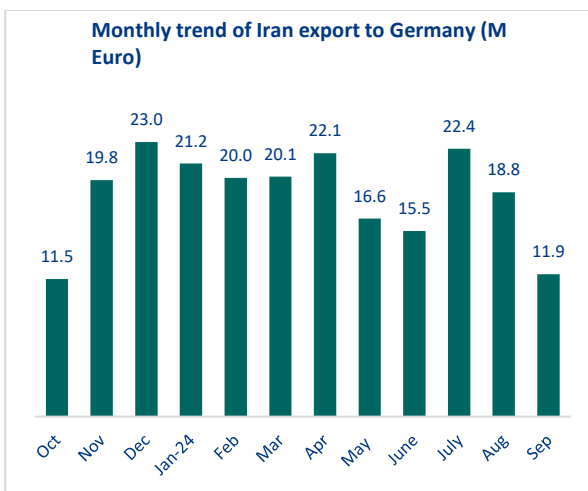
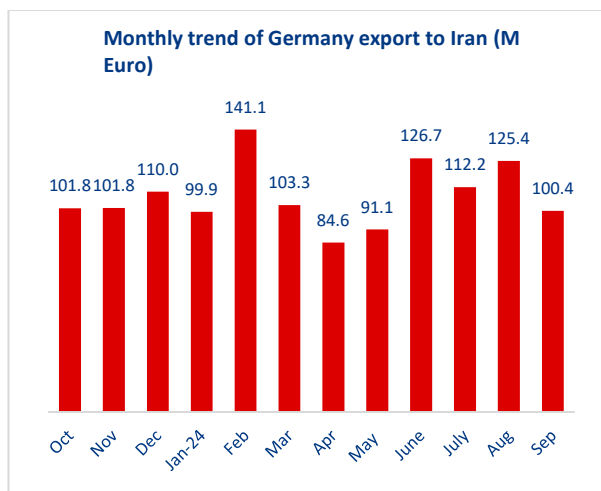


Trade between Iran and Germany - January to September 2024

- Trade volume from January to September 2024: 1.15 billion euros, **+7 percent** compared to the same period last year (1.08 billion euros)
 - German exports: 982 million euros, **+11 percent** compared to the same period last year (886 million euros)
 - Iranian exports: 170 million euros, **-11 percent** compared to the same period last year (190 million euros)
- Trade volume in September 2024: 112 million euros, **-18 percent** compared to the same month last year (138 million euros)
 - German exports: 100 million euros, **-18 percent** compared to the same month last year (122 million euros)
 - Iranian exports: 12 million euros, **-25 percent** compared to the same month last year (16 million euros)
