

Trade between Iran and EU 27 - January to September 2024


- Trading volume from January to September 2024: 3.5 billion euros, +1 percent compared to the same period last year (3.4 billion euros)
 - European exports: 2.8 billion euros, no change compared to the same period last year (2.8 billion euros)
 - Iranian exports: 630 million euros, +6 percent compared to the same period last year (595 million euros)
- Trading volume in September 2024: 352 million euros, **-9 percent** compared to the same month last year (387 million euros)
 - European exports: 283 million euros, -14 percent compared to the same month last year (329 million euros)
 - Iranian exports: 69 million euros, +19 percent compared with the same month last year (58 million euros)












Iran Export to EU-27 Jan to Sep 2024 (M. €)
