


Trade between Iran and EU 27 - January to October 2024

- Trading volume from January to October 2024: 3.77 billion euros, **-1 percent** compared to the same period last year (3.8 billion euros)
 - European exports: 3.07 billion euros, -2 percent compared to the same period last year (3.14 billion euros)
 - Iranian exports: 698 million euros, +6 percent compared to the same period last year (654 million euros)
- Trading volume in October 2024: 300 million euros, **-19 percent** compared to the same month last year (369 million euros)
 - European exports: 235 million euros, -24 percent compared to the same month last year (310 million euros)
 - Iranian exports: 65 million euros, +9 percent compared with the same month last year (60 million euros)





