


## Trade between Iran and EU 27 - January to November 2024


- Trading volume from January to November 2024: 4.15 billion euros, -3 percent compared to the same period last year (4.26 billion euros)
  - European exports: 3.37 billion euros, -4 percent compared to the same period last year (3.52 billion euros)
  - Iranian exports: 773 million euros, +5 percent compared to the same period last year (738 million euros)
- Trading volume in November 2024: 377 million euros, -19 percent compared to the same month last year (467 million euros)
  - European exports: 299 million euros, -22 percent compared to the same month last year (383 million euros)
  - Iranian exports: 78 million euros, +7 percent compared with the same month last year (84 million euros)

EU-27 Export to Iran Jan to Nov 2024 (M. €)




Iran Export to EU-27 Jan to Nov 2024 (M. €)
