

## Trade between Iran and EU 27 – January to March 2025

- Trading volume from January to March 2025: 1.03 billion euros, -19 percent compared to the same period last year (1.2 million euros)
  - European exports: 827 million euros, -22 percent compared to the same period last year (1059 million euros)
  - Iranian exports: 211 million euros, -3 percent compared to the same period last year (217 million euros)
- Trading volume in March 2025: 336 million euros, -22 percent compared to the same month last year (430 million euros)
  - European exports: 245 million euros, -31 percent compared to the same month last year (357 million euros)
  - Iranian exports: 91 million euros, +26 percent compared with the same month last year (72 million euros)








