


## Trade between Iran and Germany - January to April 2025

- Trade volume from January to April 2025: 430 million euros, **-17 percent** compared to the same period last year (516 million euros)
  - German exports: 349 million euros, -19 percent compared to the same period last year
    (432 million euros)
  - Iranian exports: 81 million euros, -4 percent compared to the same period last year (84 million euros)
- Trade volume in April 2025: 94 million euros, **-13 percent** compared to the same month last year (108 million euros)
  - German exports: 75 million euros, -12 percent compared to the same month last year (85 million euros)
  - Iranian exports: 18 million euros, -18 percent compared to the same month last year (22 million euros)
