






## Trade between Iran and Germany - January to July 2025

- Trade volume from January to July 2025: 726 million euros, -19 percent compared to the same period last year (896 million euros)
  - German exports: 586 million euros, **-21 percent** compared to the same period last year (758 million euros)
  - Iranian exports: 140 million euros, **+1 percent** compared to the same period last year (139 million euros)
- Trade volume in July 2025: 107 million euros, -24 percent compared to the same month last year (142 million euros)
  - German exports: 83 million euros, -30 percent compared to the same month last year (119 million euros)
  - Iranian exports: 24.3 million euros, +8 percent compared to the same month last year (22.5 million euros)
