Trade between Iran and Germany - January to September 2025

- Trade volume from January to September 2025: 914 million euros, **-21 percent** compared to the same period last year (1153 million euros)
 - German exports: 735 million euros, **-25 percent** compared to the same period last year (984 million euros)
 - Iranian exports: 179 million euros, **+5 percent** compared to the same period last year (170 million euros)
- Trade volume in September 2025: 99 million euros, **-12 percent** compared to the same month last year (112 million euros)
 - German exports: 79 million euros, **-21 percent** compared to the same month last year (110026 million euros)
 - Iranian exports: 20 million euros, **+65 percent** compared to the same month last year (12 million euros)
