





Trade between Iran and EU 27 – January to September 2025

- Trading volume from January to September 2025: 2.82 billion euros, -19 percent compared to the same period last year (3.1 million euros)
 - European exports: 2.22 billion euros, -22 percent compared to the same period last year
 (2.84 billion euros)
 - Iranian exports: 595 million euros, -6 percent compared to the same period last year (630 million euros)
- Trading volume in September 2025: 326 million euros, **-7 percent** compared to the same month last year (350 million euros)
 - European exports: 262 million euros, -7 percent compared to the same month last year (281 million euros)
 - Iranian exports: 63 million euros, -8 percent compared with the same month last year (69 million euros)


