



## Trade between Iran and Germany - January to October 2025

- Trade volume from January to October 2025: 995 million euros, -20 percent compared to the same period last year (1245 million euros)
  - German exports: 795 million euros, **-25 percent** compared to the same period last year (1060 million euros)
  - Iranian exports: 201 million euros, +8 percent compared to the same period last year (185 million euros)
- Trade volume in October 2025: 83 million euros, **-9 percent** compared to the same month last year (91 million euros)
  - German exports: 62 million euros, -18 percent compared to the same month last year (76 million euros)
  - Iranian exports: 21 million euros, +39 percent compared to the same month last year (15 million euros)
