




Trade between Iran and Germany - January to November 2025

- Trade volume from January to November 2025: 1.1 billion euros, **-20 percent** compared to the same period last year (1.37 million euros)
 - German exports: 873 million euros, **-25 percent** compared to the same period last year (1161 million euros)
 - Iranian exports: 217 million euros, **+4 percent** compared to the same period last year (208 million euros)
- Trade volume in November 2025: 96 million euros, **-23 percent** compared to the same month last year (124 million euros)
 - German exports: 79 million euros, **-22 percent** compared to the same month last year (101 million euros)
 - Iranian exports: 17 million euros, **-28 percent** compared to the same month last year (23 million euros)
