





Trade between Iran and EU 27 – January to November 2025

- Trading volume from January to November 2025: 3.4 billion euros, **-19 percent** compared to the same period last year (4.1 million euros)
 - European exports: 2.67 billion euros, **-21 percent** compared to the same period last year (3.37 billion euros)
 - Iranian exports: 700 million euros, **-9 percent** compared to the same period last year (773 million euros)
- Trading volume in November 2025: 276 million euros, **-26 percent** compared to the same month last year (375 million euros)
 - European exports: 234 million euros, **-21 percent** compared to the same month last year (297 million euros)
 - Iranian exports: 42 million euros, **-46 percent** compared with the same month last year (78 million euros)
